Important Information for New Campers: All new campers and any applicants who have not participated in a Triumph Center program within the last year are required to go through an intake interview. There is a non-refundable interview fee of \$150.00. The primary purpose of the interview is to determine the camper's individual needs, confirm program suitability, and assist in determining the most appropriate group placement. It's important to note that an interview doesn't guarantee acceptance into our program. Our staff will contact you directly to set up an interview.

Payment: A non-refundable deposit of \$1400.00 must be paid to Triumph Center within one week of acceptance in order to hold a space for your child. **A bill for the balance due will be sent to you. The total balance due must be paid in full by May 17, 2024.** If payment is not received by the due date, the child will be placed on a waiting list and may not begin camp until the balance is paid.

Family Discount:

\$50 per week discount for each additional child from the same family when family is paying.

I understand that my child has not been accepted to camp until I receive written notification. I understand that all tuition payments, including the deposit are non-refundable, and Camp Triumph will not provide any refunds for any illness or quarantine-related absences. I understand that my child cannot attend camp unless valid health and immunization forms are on file. I understand my child must follow all Camp Triumph Health & Safety protocols. I understand that payment in full is due by **May 17, 2024** to secure my child's place in camp, unless otherwise agreed upon in writing by the camp. I authorize Camp Triumph staff to transport my child to the swim facility or to field trips within approximately a 30-minute proximity of camp. I agree to allow my child to go on camp-sponsored field trips. I will notify the camp if I do not want my child to go on any field trips. I give Camp Triumph permission to videotape and/or photograph my child. Videotapes and photographs will be for internal use only and will not be used for any promotion of the camp unless specifically authorized. While some schools or agencies may choose to fund Camp Triumph, I understand that I am ultimately financially responsible for all Camp Triumph fees.
