### Camp Triumph Application Process

- Complete and submit the [Camp Triumph Application Form](#) by mail or drop off (36 Woburn St., Reading, MA, 01867), by email ([camptriumphma@gmail.com](mailto:camptriumphma@gmail.com)), or by fax (781-944-6535).
- *All new campers and any applicants who have not participated in a Triumph Center program within the last year must complete an intake interview. There is a non-refundable interview fee of \$150.00.* The primary purpose of the interview is to determine the camper's individual needs, confirm program suitability, and assist in determining the most appropriate group placement. It is important to note that an interview does not guarantee acceptance into our program. Our staff will contact you directly to set up an interview.
- Notification of application status is sent via email or mail.

### Registration Policies

- Once your child receives written acceptance, decisions about camp enrollment must be made within one week.
  - When a family funds, a completed Registration Form along with the non-refundable deposit of 50% of tuition are required to enroll. A bill for the balance will be sent to you. Allowable forms of payment are check, cash, and electronic check (ACH).
  - When a school/agency funds, a signed contract from the funder and family-completed Registration Form are required to enroll.
- Registration forms can be submitted by mail or drop off, email, or fax.
- The total balance must be paid in full by **May 16, 2025**. If full payment is not received by the due date, your child will be placed on our waiting list and placement in camp is not guaranteed.
- For registrations after May 16, 2025, full payment must accompany enrollment.

### Discounts

- **Early Bird Discount: Apply on or before Friday, January 31, 2025, to lock in last year's rates!**
- **Social Skills Group Discount:** \$50 per week discount for each camper who was enrolled in the Social Skills Group Program for 1 or more 14-week sessions during the 2024-2025 academic year.
- **Family Discount:** \$50 per week discount for each additional child from the same family when the family is paying for the program.
